I further agree that I will pay my membership fees when due, and in accordance with the regulations set down concerning such dues, and that the fees paid will cover the term for that period only, and that no credit or refund in any form shall be made should I not attend classes for whatever reason.

Dove Taekwondo agrees to provide instruction in Taekwondo to the member during the scheduled instruction hours of Dove Taekwondo. The member understands that it is their responsibility to attend instruction sessions and small group; the course fee stated above is due and payable in advance, whether or not the member chooses to attend sessions. Members should take a promotion test upon the recommendation of the Instructor. Members agree to abide by the rules and regulations governing the conduct and operation of instruction sessions, students, and observers, in order to promote efficiency, safety, and recognition of the instruction certification, as prescribed by Dove Taekwondo.
